ELIGIBILITY:-

(a) Students with total stamps inside best 1% of their Class XII examination of any State/Central Board in India are qualified. 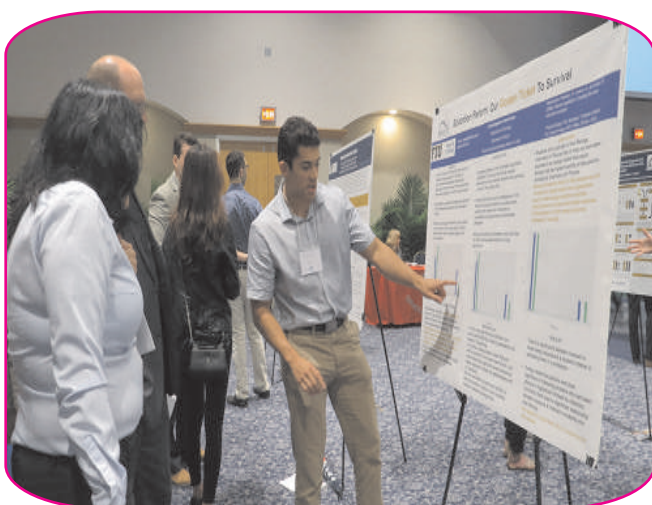

VALUE :-

TENURE:-

Terms of Research Projects to be undertaken by all the INSPIRE scholars:-

The fundamental goal of INSPIRE/SHE program is to urge youthful understudies to seek after Research as a profession. To do extend work under a Research Supervisor (Mentor) amid summer excursion period in any perceived Universities or Institutes or Research Laboratories/Centers of their decision either in India or abroad, (ideally outside their parent organizations), the Scholar will meet all requirements for accepting help from the Mentorship Grant. Now and again Scholar may benefit institutional game plan; generally Scholar should need to orchestrate both Mentoring Organization and Mentor to do this. Consumables required to complete venture work, in the event that suggested by the Mentor, will be paid from the Mentorship Grant, either to the Organization where extend work is sought after or to the Scholar specifically.
