But these manifestations are only the superficial symptoms of a breakdown in the intimate relationships within the family. The legal or social function of the normal family life may be maintained even when these personal relationships are at a minimum. Family may continue to live under the same roof duty towards children or fear of disapproval of parents may keep them together. In some cases, the outward family life may be maintained while affectionate interests are satisfied elsewhere. At the same time it must be recognized that every normal family experiences



conflicts which it is expected to overcome because of religious beliefs or economic or social motives which may prompt the wife or the husband to live in the marriage bond from which love and affection have since long fled.
